Section 1 - Allowable Judge/Rep Fees:

- **Judge Fee:** \$250 per show max (American Bullies)
 - **Sr. Judge Fee:** \$350 per show max (American Bullies)
 - Additional breeds/class \$25.00 each breed (i.e.: French Bulldog, Shortybull, English Bulldog, Olde. Etc.) must be at least (10) in the breed competing, or up to 4 breeds with less than 10 dogs would be equal 1 breed. Jr. Handlers can not be charged for unless the host charges for them to show.
 - **Lead Rep Fee:**
 - \$200 first show
 - \$50 per additional show they physically ring steward
 - **Second Rep Fee:** (if applicable):
 - \$125 first show
 - \$50 per additional show they physically ring steward

Section 2 – Additional Allowable Fees:

Hotel fees – If rep or judge is driving less than 4 hours away – they should be accommodated for up to 1 night, more than 4 hours away - up to two nights and overseas - up to three nights – set up by host and paid directly to hotel by host. *If Airbnb is secured all judges/ reps staying there must agree prior to securing.*

Airline Flight – arranged and paid by host, if flying to show

- **Airport parking** - \$15 per day maximum, unless able to provide receipts

OR

- **Driving Expense** – \$.50 per mile max allowed, if driving to show with personal vehicle only - this is all inclusive you cannot charge extra for rental car.
 - If rental car is needed, this must be arranged and okayed by the host. All receipts must be provided
 - If a rental car is agreed upon it should be one sum (rental car fee & fuel with receipts), you cannot charge mileage fee in addition to rental car costs

Meals - 3 meals per day, host either provides or pays \$50 for a full day, \$25 for half day

- Food voucher of \$20 for long flights with layovers

HOST IS EXPECTED TO MAKE SURE WHILE AT THE SHOW THE JUDGE AND REP ARE FED AND TAKEN CARE OF.

If a rep or judge cancels a show less than 30 days out and you have a signed agreement with said judge/rep, that judge or rep is responsible to refund the host if airplane tickets were purchased. Also, if said host cancels a show less than 30 days out and the judge/rep has a signed agreement, the host will be fined \$100.00 by the ABKC, which will then be reimbursed to the judge/rep for their inconvenience. (These fees can be waived if there was a true unavoidable emergency, but you must provide proof)
