- Applications must be received 60 days prior to the show no later than 30 days. If received in less, then 60 days but before 30 days there is a \$100.00 late fee to be included in Show fee. All show applications turned in under 30 days will not be accepted.
- Shows will not be posted until fees are paid and a completed show application has been received. Within 60
 Days of the event we must have a copy of the venue contract, 30 days from event date we must have insurance
 certificate, all judges and rep agreements completed and signed by both parties. If these are not received the
 show will be taken off the website and will be deemed non sanctioned by the ABKC.
- I understand ABKC has the right to refuse or revoke any dog registration as deemed necessary.

 - 5 Shows \$300.00
 - 6 Shows \$350.00
